At ABNY, we we always been advocates for making New York City a better place to live, work and visit. We we also always supported the interests of our broad and diverse membership whether through testimony, letter writing or press releases. If there are issues that you are managing where ABNY support could be helpful, please let us know.

- Cornell NYC Tech Recommendation Letter on January 15, 2013, ABNY Executive Director Jennifer Hensley sent a letter to Manhattan Borough President Scott Stringer recommending approval of the Cornell NYC Tech campus on Roosevelt Island.
- Madison Square Garden Permit Renewal Support Letter ó on February 5, 2013, ABNY Executive Director Jennifer Hensley sent a letter to Community Board 5 in support of renewing Madison Square Gardenøs special permit.
- Mixed Martial Arts Support Letter -- On February 25, 2013, ABNY Executive Director Jennifer Hensley sent letters to New York State Senators Dean Skelos and Jeffrey Klein, and to Assembly Speaker Sheldon Silver in support of legalizing mixed martial arts (MMA) in New York State.
- American Airlines-US Airways Merger Support Letter on March 8, 2013, ABNY
 Executive Director Jennifer Hensley sent letters to Representatives Michael Lee and Amy
 Klobuchar in support of the American Airlines-US Airways merger.

- Staten Island Ferris Wheel/Retail Complex Support Letter ó on October 18, 2013, ABNY Executive Director Jennifer Hensley sent a letter to City Council Speaker Christine Quinn in support of the construction of the Staten Island Ferris Wheel and the building of a retail outlet complex in the borough.

2013 Other Activities:

ABNY engaged in a host of other activities throughout the year, many of which will be launched publicly in 2014. Here is an overview of those other activities we we been working on:

- Transition 2013: ABNY has been working closely with Mayor-Elect Bill De Blasio and his transition team providing feedback and ideas about policy priorities, staffing, and inauguration events.
- Center for an Urban Future Infrastructure Report: ABNY worked with RBC Capital Markets to secure funding for CUF¢s õstate-of-good-repairö infrastructure report that will be issued in early 2014. The study is an attempt to assess the priority and scope of infrastructure challenges in the city facing the new Mayoral Administration that are not related to Hurricane Sandy recovery or resiliency planning.
- ABNY / NY Tech Meetup Tech Study: Weøve engaged HR&A Advisors to do a comprehensive study of tech jobs in New York City. This report will look beyond the tech sector and measure industries where New York has traditional strengths (financial services, media, healthcare, etc.) and measure how the jobs in those industries have

increasingly been migrating to technical positions and what their impact on our cityøs economy is.

- Education Reform: ABNY hosted NY State Education Commissioner John King and has been actively working with education advocates on Common Core implementation, statewide teacher evaluations and other pressing issues impacting our cityøs public schools.
- Aviation and Airport Advocacy: Bill Rudin was named to the Board of Directors for the Global Gateway Alliance, a group chaired by Joe Sitt advocating for improved customer experiences at our regionos airports. Jen Hensley has been representing Bill on the board and has authored an opinion piece published in Crainos New York Business. Jen also sat on a panel at the US Travel Association on infrastructure investment in the nationos airports, and has provided background and quotes for numerous publications all related to enhancing the regionos airports.
- New York State Tax Commission: Bill Rudin was tapped to sit on Governor Cuomoøs tax commission co-chaired by former Governor George Pataki and former State Comptroller Carl McCall. The tax commission is tasked with evaluating ways to redistribute anticipated budget surpluses in 2015 and 2016.
- **ABNY Small Meetings Initiatives:** ABNY hosted several small meetings this year including US Commerce Secretary Penny Pritzker, Chairman of the US Import Export Bank Fred Hochberg, and Brookings Institute Fellow Bruce Katz. We will continue to bring this interesting programming in 2014.
